



Battery energy storage is suspended

At its October 9, , meeting, the City Council of the City of Escondido ("City") adopted an urgency interim ordinance establishing a temporary prohibition on new commercial battery energy storage systems ("BESS") within the City's boundaries ("Urgency Ordinance No. -12"). In the wake of the largest battery storage fire in U.S. history, Monterey County, California, is advancing a moratorium on new battery energy storage facilities following the January blaze at the Moss Landing Power Plant. After last week's lithium battery fire at an SDG& E battery storage facility in Escondido, the Board of Supervisors will consider putting a pause on future such facilities. Escondido has become the first city in San Diego County, California, to prohibit battery energy storage sites until new land use policies and standards related to BESS are developed. On October 9, the city council voted unanimously to put temporary restrictions in place for an initial 45-day period.
