Who regulates telecommunications & postal services in Lesotho? A national regulatory authority for telecommunications, broadcasting and postal services in Lesotho BOD has the ultimate responsibility for stewardship, performance and affairs of the Authority. Lesotho Communications Authority (LCA) is a statutory body, established in June , with the mandate of regulating the communications sector in Lesotho. What will the Communications Act do for Lesotho?
