Why does northern Vietnam have higher feed-in tariffs? While Northern Vietnam benefits from higher feed-in tariffs (FiTs) due to lower solar radiation, the overall system still operates on capped tariffs rather than market-based auctions. This may limit the agility of Vietnam's energy market in responding to investor needs and evolving technology costs.
